Who may attend Sängertag?

From the NASB Constitution and By-laws, ARTICLE VI, SECTION 4 - Representation

- a) Districts
 - a. Each Association District, holding at least one District Song Festival between National Song Festivals, is entitled to one (1) District Delegate to the National Association Meeting. Such representative qualifies by presenting his credentials, in writing, signed by the responsible District Officer, to The National Secretary, at least two (2) weeks prior to the National Association Meeting.
- b) Member Groups
 - a. A Member Group is entitled to one (1) Delegate for each ten (10) active singers, or portion thereof, for whom annual dues have been paid to date.
 - b. The only qualifications for such Delegates are:
 - i. They must be active singers of the Group they represent.
 - ii. They must present their credentials, in writing, signed by a responsible officer of the Group, to the National Secretary, no later than two (2) weeks prior to the National Association Meeting.
 - iii. Groups, entitled to more than one (1) Delegate, may be represented by one (1) Delegate, and all votes, to which the Group is entitled, may be cast by such single Delegate, providing such authority has been

- given in writing, signed by a responsible officer of the Group, and has been registered with the National Secretary at least two (2) weeks prior to the National Association Meeting.
- iv. Delegates, from Member Groups whose dues payments are in arrears, shall not be recognized or allowed to participate in a National Association Meeting.

c. Musical Directors

- i. Musical Directors are entitled to one (1) Delegate.
- ii. The only qualifications for said Delegate are::
 - 1. They must be an active Musical Director of a member Group and be elected through a vote of the Musical Directors of the Bund, solicited by the Secretary of the National Association.
 - 2. They must present their credentials, in writing, signed by a responsible officer of the National Association, to the National Secretary, no later than two (2) weeks prior to the National Association Meeting.
 - 3. The Musical Director's Delegate, from Member Groups whose dues payments are in arrears, shall not be recognized or allowed to participate in the meeting

It is important that we have a strong attendance at our Sängertag. Please consider sending the younger persons to the meeting to enhance the dynamics. We have to plan for the future. Our highest priority should be maintaining and growing the NASB. We can only do this with fresh ideas and active involvement.

You will note on the meeting agenda "committee" often listed. During my 18 months as president, I discovered the various committees have a staffing of 1. Let's try to spin up involvement of the membership by enlisting them to be on a committee.

We also have to select a city for our 2018 Sängertag and 2019 Sängerfest...Have you hosted in the past 10 or 20 years. It can be a fun project and the NASB Vorstand is here to assist.

Are there any further items you might like to have on the Sängertag? Just let me know.
